2. The submission of this application form must be accompanied by the stipulated non-refundable application fee which is R5000 (Five Thousand Rand) per application. Step 4: Attach proof of payment (e.g. copy of bank deposit slip or other receipt) to the application form.
3. The Department will submit your completed application for comment to the relevant provincial authority or manager of a protected area if your application affects a protected area. This is due to the co-operative governance requirements of the Constitution (Act No.108 of 1996). Provincial working groups meet monthly to evaluate applications for vehicle use in the coastal zone. The Department will in consultation with the relevant authority endeavour to process your application within a reasonable period of time, defined as 15 to 30 days, subject to inclusion of all the information required in the application form. Every effort will be made to process urgent applications within a shorter period of time, although the Department cannot guarantee that this will be possible. **You are therefore requested to submit your application form at least 30 days prior to the date on which you propose to use a vehicle(s) in the coastal zone.**
4. You must provide a detailed description of the proposed advertisement, production or filming activity indicating why the use of a vehicle in the coastal zone is required to effectively carry out the proposed activity. **Please note that permits will generally not be granted for the production of any material that depicts any use of a vehicle in the coastal zone which is not consistent with the regulations. Such use includes leisure driving in privately owned vehicles and driving in sensitive areas such as dunes and salt marshes.**
5. You must attach an independent environmental report demonstrating that:
 - 5.1 the intended vehicle use will not cause significant harm to the coastal zone environment (see Part F);
 - 5.2 members of the public will be able to continue to safely use and enjoy that part of the coastal zone affected by this application (see Part G).
6. Applicants must provide a certified copy of each of the driver's licences of those persons who will be driving the vehicle or vehicles to which this permit pertains.

7. This application must be completed and signed by the applicant. The applicant's signature must be commissioned by a Commissioner of Oaths. If the application is completed by a third party (such as a consultant or legal representative), then this third party's details must **also** be provided as required in this application.
8. This application must be addressed to the Department of Environmental Affairs and Tourism and handed in at the Department of Environmental Affairs and Tourism: Branch Marine and Coastal Management, 3rd Floor, Foretrust Building, Martin Hammerschlag Way, Foreshore, Cape Town, 8001. PART F: EFFECT ON THE ENVIRONMENT

As a general rule vehicle use will not be permitted in areas considered sensitive or inappropriate. Such areas are listed in paragraph 5.11 of the Department's Guidelines on the Implementation of Regulations pertaining to the Control of Vehicles in the Coastal Zone. Proposals to use vehicles in such areas will therefore require adequate motivation.

You must attach an independent environmental report demonstrating that the intended vehicle use will not cause significant harm to the coastal environment. The report must be compiled by a qualified environmentalist who may be an independent consultant or an employee of a local, provincial or national authority. The compiler of the environmental report is advised to consult with the local authority having jurisdiction over the area affected by the application. Should such local authority lack expertise in environmental management, it should refer the report's compiler to the relevant provincial environmental authority. If the area affected by the application is located in a protected area, the manager of such protected area should be consulted. The relevant authority's comments should be included in the report (see also Part G below).

If the compiler of the environmental report supports the application, he/she should advise the applicant regarding conditions for vehicle use to avoid harm to the environment. These conditions must be included in the report.

PART G: RIGHTS OF THE PUBLIC

In this regard consideration must be given to the extent to which the area concerned is used for recreation and consideration must be given to the nature of such recreation.
