**MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998)**

I, Marthinus van Schalkwyk, Minister of Environmental Affairs and Tourism, acting in consultation with the Minister of Finance, hereby under section 25 of the Marine Living Resources Act, 1998 (Act No. 18 of 1998) ("the Act"), determine the fees payable in respect of applications for and the issuing or granting of rights, permits and licences in terms of the Act as set out in the Schedule.

**SCHEDULE**

**1. APPLICATION FEES**

(a) Fee payable in respect of an application for a right to –

(i)	undertake commercial fishing (including the harvesting of seaweed).	R 7000
(ii)	operate a fish processing establishment.	R 7000
(iii)	engage in mariculture.	R 7000
(iv)	undertake commercial fishing of no more than 60 000 oysters using no more than four harvesters.	R 585
(v)	undertake commercial fishing of white mussels for bait purposes.	R 585
(vi)	undertake commercial fishing by means of small nets (beach seine for mixed shoal fish, drag, gill, drift, cast and shove).	R 585
(vii)	undertake commercial fishing of 850 kg or less abalone.	R 585
(viii)	undertake commercial fishing of 1.5 tonnes or less west coast rock lobster.	R 585
(ix)	undertake commercial fishing of linefish (traditional) with no more than four crew.	R 585
(x)	undertake subsistence fishing.	R 5

(b) Fee payable in respect of an application for a medium/long term renewable permit to view sharks by conducting shark cage diving: R7 000

- (c) Fee payable in respect of an application for a medium/long term renewable permit to conduct boat based whale watching: R7 000

(Please note that 1(b) and 1(c) are only to be paid on application for medium/long term permits. Once the medium/long term permits have been allocated there will be an annual application fee payable to renew the permits as well as an annual permit fee)

- (d) Fee payable in respect of an application for a permit to exercise a right granted to –
- (i) undertake commercial fishing (including seaweed): R120;
  - (ii) operate a fish processing establishment: R120;
  - (iii) engage in mariculture: R120;
  - (iv) to undertake subsistence fishing: R5.
- (e) Fee payable in respect of an application for a permit to undertake recreational fishing: R5.
- (f) Fee payable in respect of an application for a permit by a person other than a South African person (does not include permits issued in terms of an international agreement) –
- (i) to undertake fishing or related activities: R9 300;
  - (ii) to undertake exploratory fishing: R930.
- (g) Fee payable in respect of an application for a permit from a holder of a commercial fishing permit to transfer any fish or any part or product thereof from any landing point: R120.
- (h) Fee payable in respect of an application for a permit to have any gear, stake net, setnet, gillnet, bottom trawl/net, midwater trawl/net, purse seine net, purse net, longline or any type of rock lobster net on board of a fishing vessel or a vessel: R 120.
- (i) Fee payable in respect of an application for a permit to import any fish or any part or product thereof on a recreational basis (recreational fishers): R35
- (j) Fee payable in respect of an application for a permit to perform an activity in terms of the Act not mentioned in paragraph (b)-(i) above: R70.
- (k) Fee payable in respect of an application for a local fishing vessel licence: R120.
- (l) Fee payable in respect of an application for a high seas fishing vessel licence: R120
- (m) Fee payable in respect of an application for a foreign fishing vessel licence (does not include vessels licensed in terms of an international agreement)

- (i) in respect of a vessel to be utilised in a joint venture arrangement with a South African person: R930;
- (ii) in respect of a vessel to be utilised by a foreign company: R9 300;
- (iii) in respect of a vessel to be utilised for exploratory fishing: R930.

## 2. PERMIT FEES

- (a) Fee payable in respect of the issuing of a permit to exercise a right to –
  - (i) undertake commercial fishing (including seaweed): R640;
  - (ii) operate a fish processing establishment: R1 280;
  - (iii) engage in mariculture: R1 280;
  - (iv) undertake subsistence fishing: R30.
- (b) Fee payable in respect of the issuing of a permit –
  - (i) to undertake high seas fishing: R640.
  - (ii) authorising a person other than a South African person to undertake fishing in South African waters (does not include permits issued in terms of an international agreement): R23 200;
  - (iii) authorising a foreign person to take part in exploratory fishing in South African waters: R930.
- (c) Fee payable in respect of the issuing of a permit to undertake recreational fishing of –

(i)	abalone	R 65
(ii)	west coast rock lobster	R 65
(iii)	east coast rock lobster	R 65
(iv)	molluscs including octopus, squid, worms, other invertebrates and aquatic plants	R 65
(v)	mud crab	R 65
(vi)	marine aquarium fish	R 65
(vii)	angling	R 50
(viii)	spearfishing	R 65
(ix)	use of cast or throw net	R 65
(x)	additional fee per vessel (only payable by the skipper) for recreational fishing from such a vessel where applicable	R 65

- (d) Fee payable in respect of the issuing of a short term permit (only valid for four weeks) to undertake recreational fishing of –
- (i) molluscs including octopus, squid, worms, other invertebrates and aquatic plants R35;
  - (ii) mud crab R35;
  - (iii) marine aquarium fish R35;
  - (iv) angling R30;
  - (v) spearfishing R35;
  - (vi) use of cast or throw net R35;
  - (vii) additional fee per vessel (only payable by the skipper) for recreational fishing from such a vessel where applicable R35.
- (e) Fee payable in respect of the issuing of a permit to conduct boat based whale-watching –
- (i) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry five or less than five paying passengers: R3 240;
  - (ii) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry six to 10 paying passengers: R6 400;
  - (iii) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry 11 to 20 paying passengers:  
  
A base fee of R6 400 plus R1 860 for each additional paying passenger more than 10 that the vessel is registered to carry;
  - (iv) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry 21 or more paying passengers: R29 300.
- (f) Fee payable in respect of the issuing of a permit to view sharks by conducting shark cage diving -
- (i) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry 12 or less than 12 paying passengers: R14 100
  - (ii) vessels licensed in terms of the relevant legislation and registered by SAMSA to carry more than 12 paying passengers:  
  
A base fee of R 14 100 plus an additional fee of R 1 120 for each paying passenger more than 12 that the vessel is registered to carry.

"SAMSA" means the South African Maritime Safety Authority established by section 2 of the South African Maritime Safety Authority Act, 1998 (Act No. 5 of 1998).

- (g) Fee payable in respect of the issuing of a permit to a holder of a commercial fishing permit to transfer any fish or any part or product thereof from any landing point: R145
- (h) Fee payable in respect of the issuing of a permit to have any gear, stake net, setnet, gillnet, bottom trawl net, midwater trawl net, purse seine net, purse net, longline or any type of rock lobster net on board of a fishing vessel or a vessel: R145
- (i) Fee payable in respect of the issuing of a permit to import any fish or any part or product thereof on a recreational basis (recreational fishers): R75
- (j) Fee payable in respect of the issuing of a permit to perform any other activity in terms of the Act not mentioned in paragraphs (a), (b), (c), (d), (e), (f), (g) (h) and (i): R70.

### 3. LICENCE FEES

- (a) Fee payable in respect of the issuing of a licence for a local fishing vessel with a length of –
  - (i) 5 metres and less: R205;
  - (ii) more than 5 m to 8 metres: R290;
  - (iii) more than 8 m to 12 metres: R465
  - (iv) more than 12 m to 20 metres: R875;
  - (v) more than 20 metres: R1 400.
- (b) Fee payable in respect of the issuing of a high seas fishing vessel licence: R1 510.
- (c) Fee payable in respect of the issuing of a foreign fishing vessel licence (does not include vessels utilised in terms of an international agreement): R11 100.

### 4. OTHER FEES

- (a) Fee payable in respect of the transfer of a right or licence: R145.
- (b) Fee payable in respect of the issuing of a new right, licence or permit due to the amendment of the terms or conditions of the existing right, licence or permit at the request of the holder: R145.

- (c) Fee payable in respect of the issuing of a permit to import fish on a commercial basis: R145.
- (d) Fee payable in respect of the issuing of a permit to export fish: R145.
- (e) Fee payable in respect of the issuing of a duplicate licence or permit: R35.
