I, Bomo Edith Edna Molewa, Minister of Environmental Affairs, hereby consult on my intention to appoint the Environmental Assessment Practitioners Association of South Africa as a registration authority in terms section 24H(3)(a) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) for a period of 5 years, while I consider options for the long term regulation of environmental assessment practitioners. I intend to limit, in terms of section 24H(6) of the National Environmental Management Act, 1998 (Act No. 107 of 1998), the appointment of registration authorities to the Environmental Assessment Practitioners Association of South Africa as the only registration authority for a 5 year period.
