**NATIONAL ENVIRONMENTAL MANAGEMENT: AIR QUALITY ACT, 2004  
(ACT NO. 39 OF 2004)****AMENDMENT OF THE NATIONAL POLLUTION PREVENTION PLANS REGULATIONS, 2017**

I, Bomo Edna Edith Molewa, Minister of Environmental Affairs, in terms of section 55(3)(b) of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004), hereby amend the National Pollution Prevention Plans Regulations, 2017, as set out in the Schedule hereto.

**SCHEDULE****Definition**

1. In these regulations "the Regulations" means the National Pollution Prevention Plans Regulations, 2017, published under Government Notice No. 712 of 21 July 2017.

**Amendment of regulation 4 of the Regulations**

2. Regulation 4 of the Regulations 2017 is hereby amended by the substitution of subregulation (1) of the following subregulation:

"(1) A person must submit a first pollution prevention plan to the Minister **[within five months from the date of promulgation of these Regulations] before or on 21 June 2018** and the subsequent pollution prevention plans must be submitted within five months of existing plans being reconciled".
