**INTENTION TO DECLARE CERTAIN LAND SITUATED IN THE HUMANSDORP, KNYSNA AND
GEORGE REGISTRATION DIVISION, EASTERN AND WESTERN CAPE PROVINCES AS PART
OF THE PROPOSED GARDEN ROUTE NATIONAL PARK**

I, Marthinus Christoffel Johannes van Schalkwyk, Minister of Environmental Affairs and Tourism, by virtue of the powers vested in me under section 20(1) hereby give notice in terms of section 33(1)(a) of my intention to declare the properties listed in the Schedule as part of the proposed Garden Route National Park.

I also intend including the already declared Wilderness and Tsitsikamma National Parks into the consolidated Garden Route National Park.
